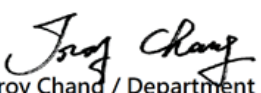

PFAS Remark :

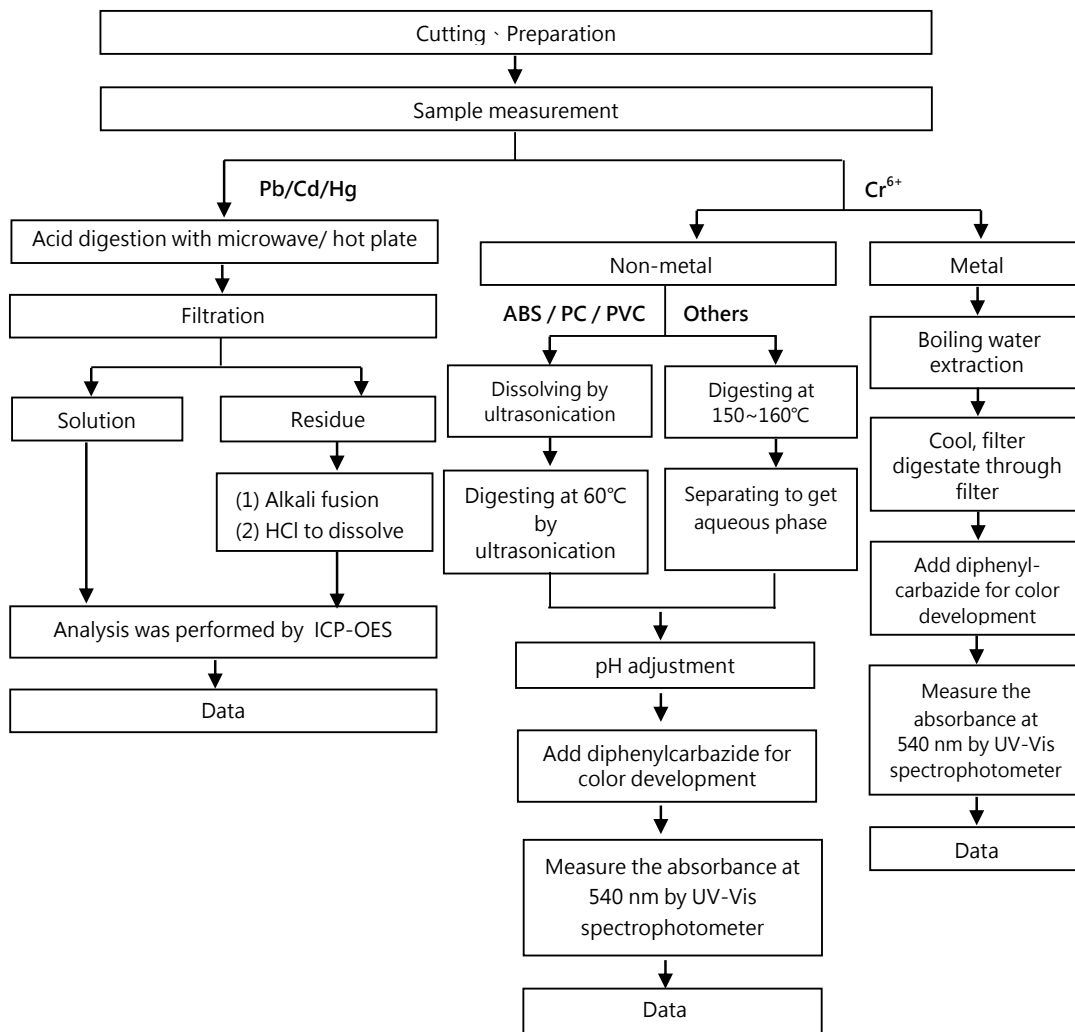

Analytical flow chart of heavy metal

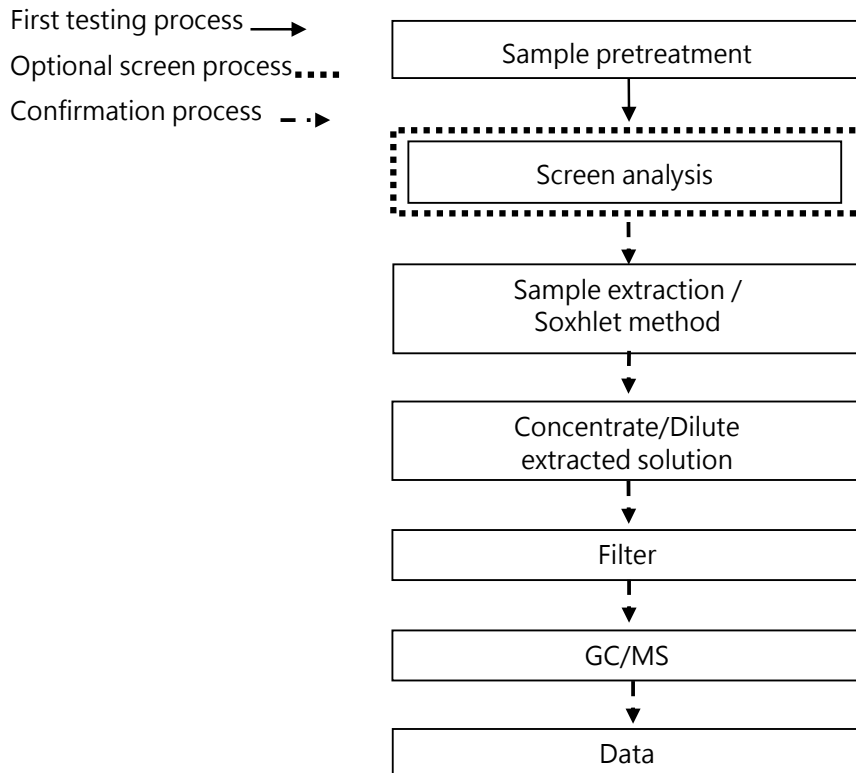

Analytical flow chart – PBBs / PBDEs

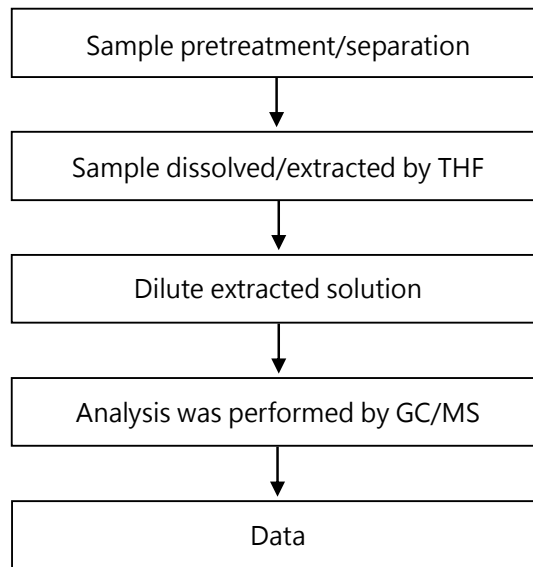

Analytical flow chart - Phthalate

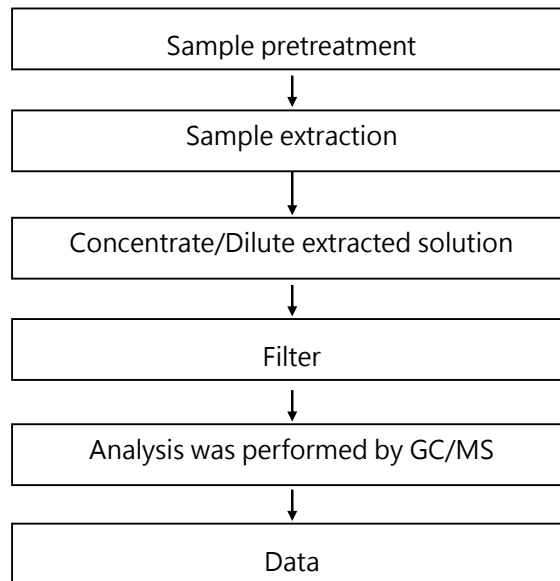

Analytical flow chart - HBCDD

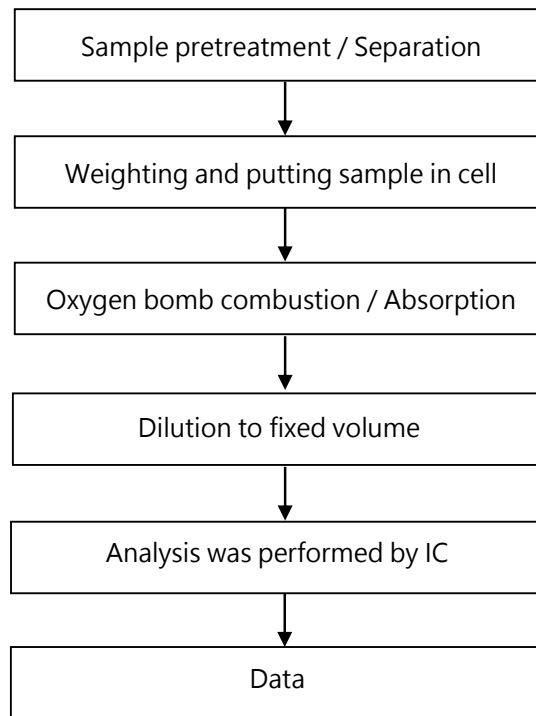

Analytical flow chart - Halogen

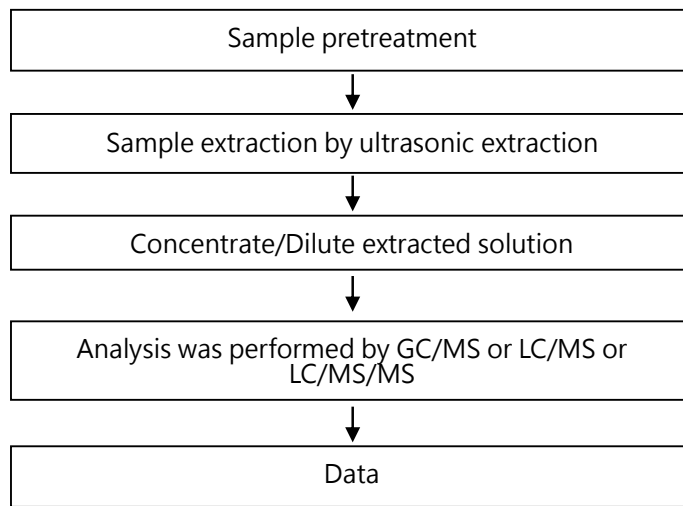

Analytical flow chart – PFAS (including PFOA/PFOS/its related compound, etc.)

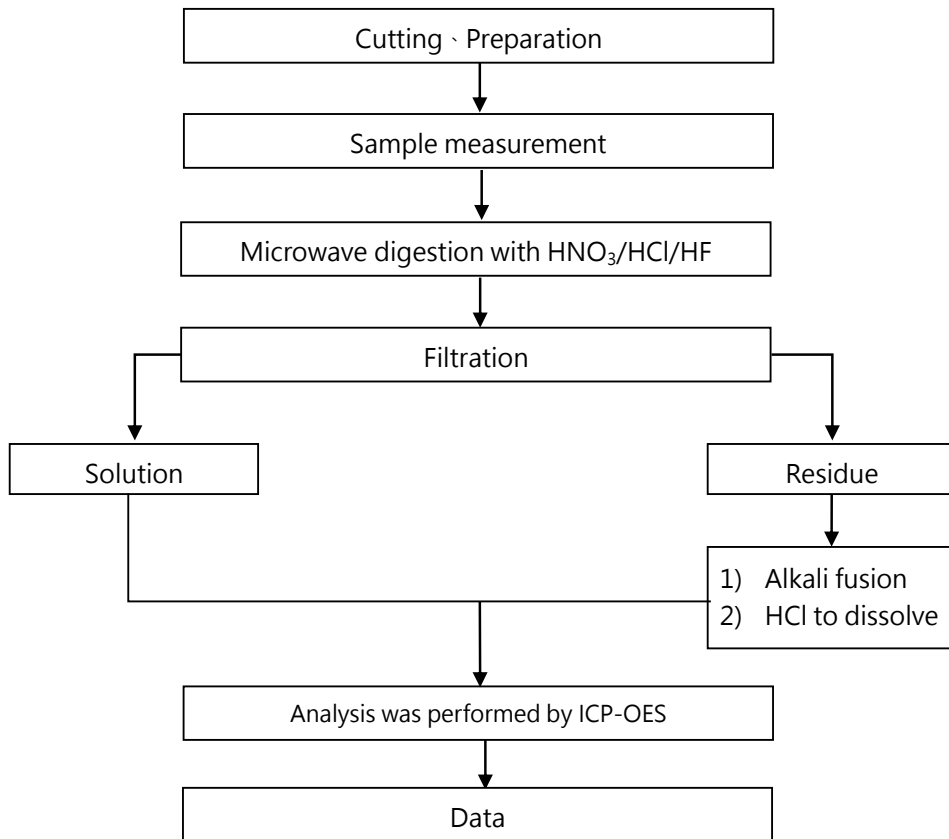
