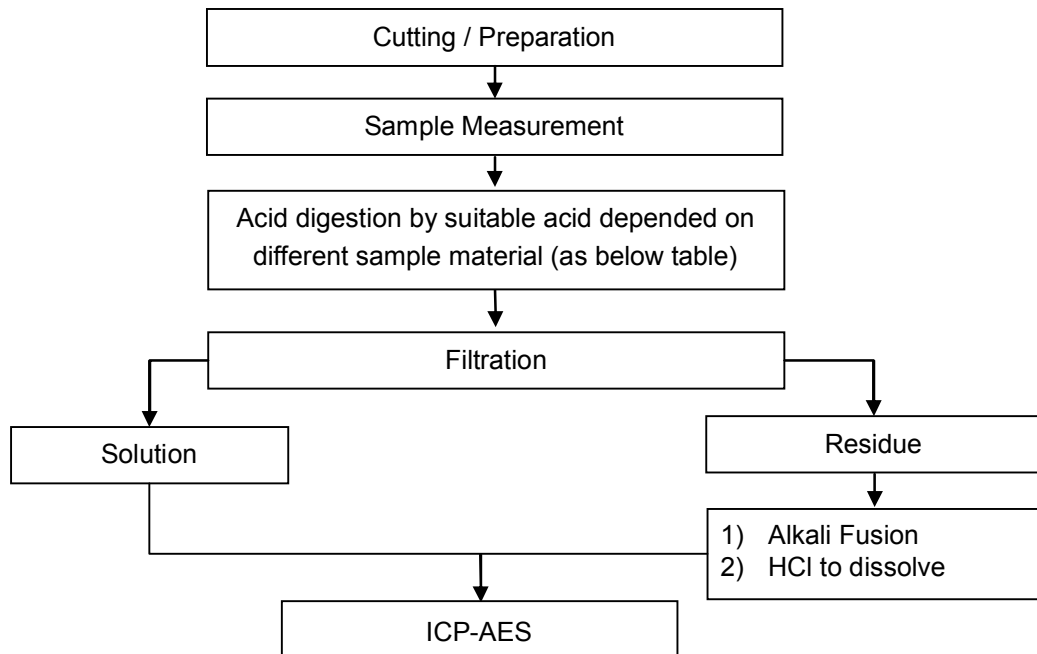

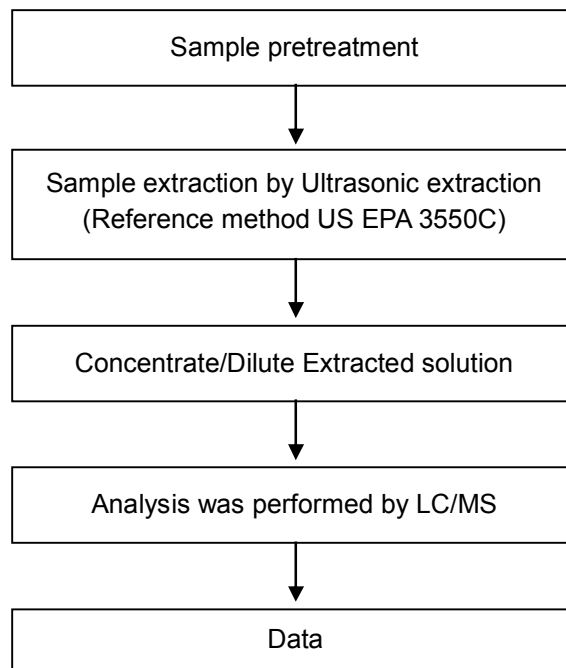

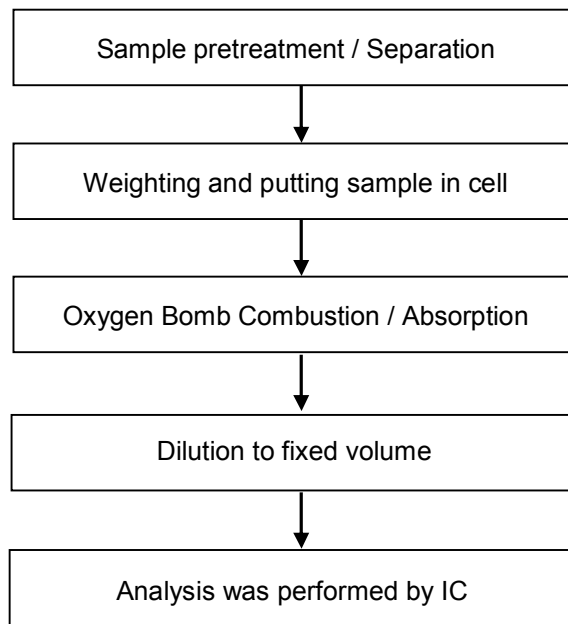

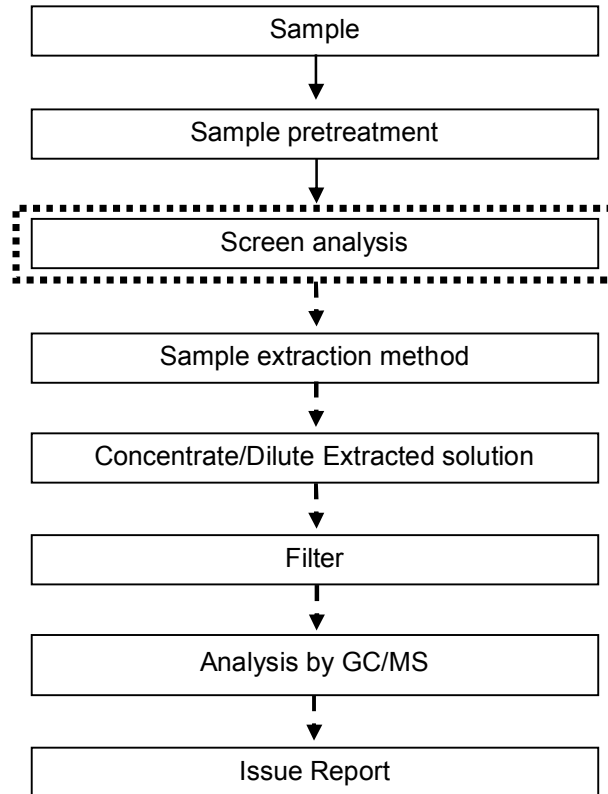


Analytical flow chart
